Update on RPU Training Plans and CTI List

- Regional TA Plan The Regional Organizers and Regional Training Coordinators, during the RPU Planning calls, have stated that they have had other priorities due to the impact of COVID-19. Regional projects that will be affected by the plans have been put on hold due to the pandemic. We have put forth an effort to respect these entities at this time. There are two RPU's remaining that we have not had calls with that have asked to postpone and have not welcomed the call at this time. Following the conference we will do a poll to the 14 RPUs to see who is ready for us to begin to implement TA plans. What we were able to discern from the 12 RPU conversation's that we had is that, while all the plans outlined are valid, they are not urgent. Urgent work has been to adapt to COVID-19 through webinars, WORKCON and addressing matters of urgency.
- CTI List Update- The CTI RFP has been completed, and notifications have been sent out.
 Currently, CWA is obtaining information for a new CTI List, and we will have a completed
 2020-2021 CTI List by the beginning of July 2020. CWA will provide the new list on the
 CTI web page, and we will send it to everyone via Constant Contact. We understand that
 online trainings are in demand, so we will indicate them in the list. If you have any

AJCC Reopening Guidance

Recommendations are being developed by a team of State and Local practitioners. They
are meant to serve as guidelines for our State's AJCC Operators and local workforce
boards. The workgroup will continue to meet and build out the details as the State's
workforce system continues to move back to fully operational.

The workgroup understands the complexity of opening up America's Job Centers of California (AJCCs). It is clear that operators of AJCCs come from a variety of organizations and will need to adhere to and incorporate their organizational protocols and procedures around social distancing. We are aware that these procedures vary from county to county and may differ from organization to organization. We believe

that local workforce stakeholders that operate within the AJCC system will work together to identify essential services and prioritize these services based on which need to be delivered in-person.
