Table Set 4.2.1.1 shows the percentage of a program's total participants (at top) who were also participants in a second program (at left) during the fiscal year in question. For example: during FY 14-15, 0.6% of participants in CTE were also participants in ETP.

In both fiscal years, the densest cross-program participation was found among participants in WIOA Title III and the Trade Adjustment Assistance program. About 88% of participants in TAA in FY 14-15, and about 85% of the same population in FY 15-16, were also enrolled in Title III. Participation of Title III participants in the Title I Dislocated Worker program was also quite high in each year, about 75% of all Dislocated Worker participants in FY 14-15 and about 78% in FY 15-16 also Title III-enrolled.

More than one-half of all participants in the Title I Adult program in each year were also enrolled in Title III. Title III enrollment among Title I Youth participants was somewhat lower but still substantial, about 43% of all Youth participants in each year.

Another area of notable overlap was between participants in State Certified Apprenticeship who were also participants in CTE—just under one-fourth of all SCA participants in FY 14-15 and 27% in FY 15-16. In many cases, participants in apprenticeship programs take career education coursework as part of the classroom component of their training.

Apart from these cases, there was not a large extent of overlap in participation between different workforce programs in the report—a finding which is interesting in itself.
