### 3. Updates and Discussion

- A. Labor Agency Update
  - a. Subject: Update from LWDA Secretary Knox's designee, Abby Snay, on metrics for rapid response, older worker research with the Department of Aging and AARP Foundation, and youth workforce such as Cradle to Career leadership. Snay also provided updates on solicitations such as WIOA, expansion of the Emergency Medical Services Corp Program, Farm Workers Advancement Program, California Opportunity Youth Apprenticeship Program, and Allied Health. The CWDB's upcoming solicitations include a round of the Workforce Accelerator Fund and High Road Training Partnership focusing on healthcare and climate.
