

Thank you for your interest in the High Road Training Partnerships 2025 Grant Program (HRTP 2025). Applicants are strongly encouraged to review the HRTP 2025 Request for Applications (RFA) before applying for funds.

Applying for HRTP 2025 funding is a two-phase process. In Phase I, applicants must complete and submit a Pre-Application (this form) to Solicitations@cwdb.ca.gov with "HRTP 2025 Pre-Application Submission" in the subject line. Phase I Pre-Applications are due Wednesday, May 21, 2005, attentions will not be accepted.

Eligibility for HRTP 2025 is limited to applicants who meet one of the following criteria: 1) Past or current CWDB-funded HRTP projects or 2) New projects that include a labor management partnership or a project labor agreement, labor peace agreement, or community benefits agreement. Additionally, applicants' industry sector focus must align with one or more of the strategic sectors in their region(s) as identified in California's State Economic Blueprint and their respective California Jobs First Regional plan(s).

Phase I Pre-Application Instructions

The Pre-Application is a standardized form intended to collect details of the proposed project and its planned use of funds. Pre-Applications will be evaluated to determine whether applicants meet the minimum eligibility criteria outlined in the HRTP 2025 RFA.

Organizations applying for HRTP 2025 funding must respond to each applicable prompt in the Pre-Application. Responses containing text boxes must be single-spaced and in 12-point Arial font (the Pre-Application will automatically default to this formatting). Responses should directly address the prompts. Failure to respond to all applicable prompts in the Pre-Application may result in disqualification.

Phase II Application

Applicants that submit a Pre-Application during Phase I and meet the eligibility requirements as outlined in the HRTP 2025 RFA will be invited to complete a Phase II application on the Cal-E-Grants website.
