### 3. Updates and Discussion

A. Response to LA Fires: LA Rises

- a. Executive Director provided an update on the Palisades and Eaton fires. CWDB has identified 47 grantees within the LA area who have been affected by cohort management or their ability to execute their current agreements, and they are working through the process of potentially extending some of the agreements to ensure that they can facilitate the work. The Labor Workforce Development Agency deployed \$10 million for LA Rises, and there is interest in gathering supplemental funds. Discussion followed between the Board Members regarding more solutions to help rebuild and create jobs after the fires.

- C. California Jobs First
- a. Executive Director introduced the California Jobs First initiative and presented an update regarding the identified 13 regions that were designated by a public comment process which was incorporated both on the uniqueness of the territories and what assets they have. There are 13 regional plans that have been developed by over 10,000 participants at the local level with each plan offering unique ways for economic opportunity and growth within those territories. California Jobs First consists of California's Strategic Sectors which are Strengthen, Accelerate, Bet, and Anchor.
